Each food booth must have a food handler's license in order to serve. Food booths must be equipped with grease traps and fire extinguishers and a wash station (see diagram on other side). It is imperative that all food booth areas maintain a clean and sanitary cooking area at all times.

FOR BOTH ARTS & CRAFTS / NON-FOOD AND FOOD VENDORS, PROHIBITED ITEMS INCLUDE: NO home-prepared foods; NO charcoal or wood grills; NO smoking or e-cigarettes/inhaled vapor devices; NO containers made of Styrofoam or glass.

VENDOR BOOTH REQUIREMENTS: *All vendors must build their own booth. Space is limited to a 10' x 10' area. Vendor Booths must open at 6:00 p.m. on Friday and 9:00 a.m. on Saturday. You are responsible for your own tables and chairs as they will not be provided by Juneteenth Foundation, Inc. All booths must be taken down by 6:00 p.m. on Saturday, June 15, 2019. Any booths left remaining will be thrown away – no exceptions.*
