Food booths must be equipped with grease traps, if necessary, fire extinguishers, and a wash station (see diagram provided). It is imperative that all food booths maintain a clean and sanitary cooking area at all times.

#### FOR BOTH ARTS & CRAFTS / NON-FOOD AND FOOD VENDORS, PROHIBITED ITEMS INCLUDE:

**NO** home-prepared foods; **NO** charcoal or wood grills; **NO** smoking or e-cigarettes/inhaled vapor devices;  
**NO** containers made of **Styrofoam** or **glass**.

**VENDOR BOOTH REQUIREMENTS:** All vendors must build their own booth. Space is limited to a 10' x 10' area. Vendor Booths must open at 9:00 a.m. on Saturday. You are responsible for your own tables and chairs as they will not be provided by Juneteenth Foundation, Inc. All booths must be taken down by 6:00 p.m. on Saturday, June 19, 2021. Any booths left remaining will be thrown away – no exceptions.
