Each food booth must have a Food Vendor Permit to sell food, **which needs to be obtained 30 days prior to the event (May 17, 2022, is the deadline date)**, and a Food Handler’s Certificate (**classes available online**) in order to serve food. Food booths must be equipped with grease traps, if necessary, fire extinguishers, and a wash station. It is imperative that all food booths maintain a clean and sanitary cooking area at all times.

#### FOR ALL VENDOR BOOTHS, THE FOLLOWING ITEMS ARE PROHIBITED / ARE NOT ALLOWED:

- ◆ Home-prepared foods ◆ Charcoal or wood grills ◆ Smoking or e-cigarettes/inhaled vapor devices and
- ◆ Containers made of Styrofoam or glass.

**VENDOR BOOTH REQUIREMENTS:** *Space is limited to a 10’ x 10’ area. Vendor Booths must open at 9:00 a.m. on Saturday, June 18, 2022. You are responsible for providing your own tables and chairs as they will not be provided by Juneteenth Foundation, Inc. All booths must be taken down by 6:00 p.m. on Saturday, June 18, 2022. Any booths left remaining will be thrown away, and vendor will be charged clean-up fee – NO EXCEPTIONS.*
